We offer proven genetics that will optimize your cows' production and we strive to build long-lasting relationships and partnerships with satisfied customers. Your satisfaction is guaranteed with every purchase – the **best guarantee** in the industry.

Our cowherd, established in 1962, originated from the Michaelis Ranch, the first U.S. breeders of Charolais. We have maintained strong bloodlines with proven performance for many generations. Our sires are proven to excel in the essential traits of ease of calving, growth, and carcass quality, supported by data from the Canadian Conception-to-Consumer Test, AICA Sire Evaluation Test and in-depth Genomic testing. We have performance records for every calf born on this ranch since 1962, ensuring bulls with excellent calving ease, performance, fertility, and longevity.

Our focus on “ease of calving” means your bulls will work well on range conditions, producing live births and high-performing calves. Our bulls are proven to excel in feedlot gain, feed efficiency, and carcass quality. Crossbreeding with Charolais genetics adds hybrid vigor that puts extra pounds on your calves.

You can expect our mature two-year-old bulls will breed more cows earlier in your breeding season, and boost weaning weights by 50-plus pounds. Their feedlot gains are faster and more efficient, with verified superior carcasses. Our bulls lead the Charolais breed in these traits, with bulls that rank in the top 1% for Charolais Total Sire Index (TSI) and marbling.

Charolais genetics have been shown to produce the leanest, highest-yielding carcasses, and our bulls sired Montana Steer of Merit Carcass Champions over 30 years ago. The demand for Charolais-sired calves remains strong nationwide.

Through 50-plus years of focused genetic selection, we have eliminated calving problems, ensured long-lasting sound bulls, and produced cows with excellent mothering abilities and dispositions. Our bloodlines form the foundation for other top Charolais herds across the U.S. and Internationally.

Our breeding program is based on proven genetics, not big feed rations. The bulls in this sale represent the best of our **2024 calf crop**, carefully selected for fertility, performance, conformation, pedigree, soundness and disposition. Each bull is semen-tested and guaranteed to perform.

Our bulls are raised under natural range conditions nursing their mothers with no creep feeding. After weaning, the bulls are fed alfalfa-mix hay for growing during winter, then they mature on pasture under practical range conditions. They are never pushed on feed but are simply conditioned to ensure optimum breeding condition and long-term performance for you. Due to our practical manner of growing bulls, it is rare for one to go unsound.

We have great confidence in these **two-year-old** bulls and are certain we have eliminated any bull with even very minor problems during our two years of selection and culling. A Guide to Reading Our Catalog

Bulls sell in catalog order by lot number, with each tagged accordingly, with the lot number in one ear and his personal herd number (tag) in the other ear. They are tagged, tattooed and weighed at birth, with the tattoo number in the left ear corresponding to his calf tag number. Bulls are weighed and thoroughly evaluated throughout the next two years.

Birth Weight and Calving Ease - Birth weight is the best predictor of calving ease, but is influenced by dam age, genetics and nutrition. A heifer bred to the same bull for her first, second and third calves may increase the birth weight as much as five pounds per year of age, and a cow of 10 years and older may taper off in birth weight of her calf. A cow born with a high birth weight herself often passes this trait to her calves, regardless of sire. In this catalog, dam's age is provided in the pedigree to help evaluate birth weights of the bulls in this sale.

If (Hfr) is noted under the dam's name, she is a 2-year-old first-calf heifer and is bred to an easier-calving sire. If (3) is under the dam, she too is bred to an easier-calving bull and her age can affect the birth weight. If you are selecting bulls to use on heifers we suggest you select only from the ***Heifer Bull* lots 151 to 160**. For extra-easy calving of small or young cows, select from the (Hfr) and (3) dams with low birth weights.

For over 50 years we have selected bulls with shorter gestations (highly heritable), thereby allowing the calf to be born on time (in 283 days or less), so it is not growing too large inside his mother and causing calving problems. A calf will gain one pound or more per day the last 30 days of gestation, so not going overdue is very important.

Nutrition can also affect birth weight by 5 to 10 pounds. An easy winter can be followed by larger calves if the cows had it too easy and got too fat. A tough winter in which extra supplement has been pushed to the mothers, or if they stood around in confinement with no exercise, can also increase birth weights. Therefore, birth weights should not necessarily be compared from year-to-year within a herd, nor be compared to another herd with different cow size and age, or climate and management.

Weaning Weight and Growth - Weaning weights are adjusted to 205 days to ensure fairness for extra days of age, so that an early-born calf does not have extra days of growth advantage over a later born calf. Since most of these bulls are born within a short five-week period, adjustments are minimal. Selecting bulls that breed early will increase profitability. A calf born 21 days late weans about 60 pounds less at weaning, costing big dollars. For a cow-calf operation, the maximum weaning weight put across the scales from the number of cows exposed at breeding time is the key formula for your success.




18-Month Index and Development - The 18-mo. index listed in our catalog indicates the weight of these bulls at 18 months and reflects mature size and genetic growth capacity. Weaning weight indicates how big the calf was at birth plus the amount of milk his mother fed him. A year later, at 18 months of age, the bull has been on his own for about a year. Bulls are raised on alfalfa hay after weaning and then pastured on rugged terrain to develop soundness, endurance and natural muscling. This grass-based development ensures bulls are ready to travel, breed efficiently, and remain sound for years. They won't melt after turnout.

Our sane way of maturing our two-year-old bulls allows you to select a mature bull that can and will travel well in your pasture and breed more cows in a shorter breeding period. Plus, they will stay sound for more years than feedlot-fattened yearling bulls. Our catalog order is based on the 18-mo. Index of the bulls.

DISPUTES: The auctioneer will settle any disputes as to bids by declaring the bids void and reselling the animals in question.

HANDLING: All animals will be maintained prior to their sale at the risk of the cosigner. As their sale is effected, all animals will be maintained at the purchaser's risk. Insurance will be available upon request from agents attending the sale or ask sale clerks. **Insurance is always recommended on all purchases.**

BREEDERS GUARANTEE: All bulls have passed a breeding soundness and semen evaluation prior to sale. We provide a breeding season (the 90-day period immediately following turn out) guarantee on all bulls to be sound, fertile, and a reproductive breeder throughout his first breeding season. This guarantee is not an insurance or mortality policy but is a guarantee on functional fertility and soundness. It is not a substitute or replacement for poor management. We strongly recommend obtaining insurance at the time of purchase. Buyers assume all risks for running bulls together or management decisions outside genetic control.



For guarantee to apply, we ask that you or your veterinarian contact us as soon as a condition is observed and before the animal is disposed. We will work with you to determine whether to return the bull or sell him for slaughter. We will attempt to provide a suitable replacement. If one is not provided of equal or greater value, we will issue a sale credit to be used at a future sale for full purchase price less salvage value of the bull.

ANNOUNCEMENT: Announcements from the auction box take precedence over printed matter in this catalog or in other ads.

HEALTH: All animals will be cleared for health and have clearance for interstate or international shipment.



DELIVERY: Delivery is only guaranteed to central terminals such as stockyards in each area.
